Z92.7'S "NEW KIDS ON THE BLOCK TICKETS" CONTEST OFFICIAL RULES

The Station will conduct the **Z92.7's "New Kids on the Block Tickets"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:59 PM on October 29, 2021 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Texting will not increase an entrant's chances of winning. Limit one (1) entry per person per day, regardless of the method of entry chosen by a listener. Each day of the Contest, listeners may either (i) text in an entry into using a mobile device or (ii) enter online, but not both methods.
